#### MEMORANDUM OF UNDERSTANDING

#### Preamble:

The role of entrepreneurship as the driving force of economic growth is well respected world over. Entrepreneurs shape economic destiny of nations by creating wealth and employment, offering products and services and generating taxes for governments. Most of the studies on the role of entrepreneurship in economic growth suggest that there is a strong relationship between the level of entrepreneurial activities in a region and its rate of economic growth (Carree and Thurik, 1998 and 2002). 'The Global Entrepreneurship Monitor' has also showed in their report of 2002, that the national level of entrepreneurial activity has a statistically significant association with subsequent level of economic growth. The role of entrepreneurship is not limited only to creation of enterprises, but also results in augmenting wealth, jobs and income, which are the most direct indicators of economic development.

While there always is an autonomous supply of entrepreneurs in all parts of the world, however, in India, it falls short of the quantity that is necessary to adequately exploit resources to generate wealth and employment. A business friendly environment and easy entry encourage potential entrepreneurs to take firm steps towards setting up their enterprises. One survey done in year 2019 revealed that, India ranks 77th in terms of 'ease of doing businesses in the world. Though, several initiatives are in place to promote entrepreneurship, the efforts are disjointed.

Many researches were done by different scholars to identify the mechanism to develop entrepreneurs systematically. Dr. David McClelland has proved in his famous 'Kakinada Experiment' that the suitable training can provide the necessary motivation, exposure & skills to the potential entrepreneurs to get succeed in the business activity (McClelland and Winter, 1969).

It is found that lack of co-ordination between various stake holders responsible for sustainable enterprise creation like Government, Entrepreneurship Development Institutes & Financial Institutions etc. is a major hurdle in the smooth entrepreneur's development process.
